2. Each applicant must submit a **typed** essay **addressing the question in Section 3. Essay must be at least one full page and not more than two pages, double spaced.** Please submit **three (3) copies** of the essay for the judges to read. Please be sure the photocopies are legible as illegible essays will be disqualified. Essays that are hand written will be disqualified as well.
3. **All application forms must be completed and signed by the Regent of the sponsoring court.**
4. The applicant **must not mention his/her name or make any other identifying reference within the essay, on the essay, or Part IV. Failure to comply will result in disqualification.**
5. On the form sent to the regent in May, **each winner must submit the name and address of the institution he/she will attend by July 1, 2010 to Peggy Rosales, Memorial Scholarship Chairman.**
6. **ALL APPLICATIONS AND ESSAYS MUST BE POSTMARKED BY FEBRUARY 1, 2010.**
